Our History and Purpose

BFIS was founded in 1996 by insurance industry leaders with the goal of providing opportunities for Bermudians to enter the insurance industry through the provision of educational funding and training. Over the years BFIS has expanded its 'curriculum' which has developed into what is now a clear 5-step programme.

1. CAREERS INFORMATION PROGRAMME

- Presentations in all Bermuda high schools on careers in insurance
- Lunch and learns for interested students
- Networking events

2. MENTOR NETWORKING PROGRAMME

- Speed Networking events held throughout the year for high-school and college students
- Any student interested in an insurance career has access to insurance professionals for mentoring

3. SCHOLARSHIP PROGRAMME

- \$6.4 million awarded since 1996
- 158 graduated scholars working in insurance sector; 21 scholars currently in university; 16 are continuing under other funding
- Up to 10 scholarships awarded annually for students studying subjects relevant to insurance
- BFIS Scholarships range from \$5,000 \$30,000 per annum

4. INTERN PROGRAMME

- 'Intro-to-Insurance' market study programmes for sophomore up to post-graduate students
- 16 students in teams of four spend 2-3 weeks in Atlanta, Bermuda, Chicago, and London annually
- 159 Bermudian students have taken part in the programme and 99% of those who have graduated are working in insurance
- BFIS Scholars are encouraged to take advantage of this programme

5. JOB SEARCH PROGRAMME

- Helping students find vacation employment
- Helping graduates find employment
- Resumé review, circulation to industry and posting on BFIS website
